13. How do you balance cooperation with others and independent thinking? Share an example. (Try to
determine if the candidate has a cooperative attitude or is otherwise good-natured.)
14. Share an experience when you applied new technology or information in your job. How did it help your

candidate is dependable.)
16. Name a time when your patience was tested. How did you keep your emotions in check?
17. Share a time when you willingly took on additional responsibilities or challenges. How did you
successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and
can demonstrate some initiative.)
18. Share an experience you had in dealing with a difficult person and how you handled the situation.
19. Provide an example of when you were persistent in the face of obstacles.
20. Share an example of when you established and accomplished a goal that was personally challenging. What
helped you succeed?
21. Share an effective approach to working with a large amount of information/data. How has your approach
affected your company?
22. Describe an experience in which you successfully controlled the operation of a difficult system. What
made you successful?
23. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change?
(Make sure the candidate is flexible.)
24. What have you found to be the best way to monitor the performance of your work and/or the work of
