1. Share an experience in which you've successfully learned how to handle a new piece of equipment?
2. Tell me about a recent experience you've had working with your hands.
3. Describe methods you have found effective to inspect product load for accuracy and safely move it around
the warehouse or facility to ensure timely and complete delivery.
4. How do you stay fit in order to perform physical activities that are required in the workplace?
5. Share an example of a time you had to gather information from multiple sources. How did you determine
which information was relevant?
6. What kind of experience do you have moving levers or controls that operate lifting devices, such as
forklifts, lift beams with swivel-hooks, hoists, or elevating platforms, to load, unload, transport, or stack
material?
7. Name a time when you moved controls to drive gasoline- or electric-powered trucks, cars, or tractors and
transport materials between loading, processing, and storage areas.
8. Share your approach to manually or mechanically load or unload materials from pallets, skids, platforms,
cars, lifting devices, or other transport vehicles.
9. Share an experience you had in dealing with a difficult person and how you handled the situation.
10. Describe an experience in which you successfully controlled the operation of a difficult system. What
made you successful?
11. Share an example of when you went above and beyond the "call of duty". (Look for answers that show the
candidate is dependable.)
12. What is the most challenging part of operating or tending automatic stacking, loading, packaging, or
cutting machines?
13. Share an experience in which your attention to detail and thoroughness had an impact on your last

company.
14. Tell me about the last time you monitored or reviewed information and detected a problem. How did you respond?
15. Tell me about a time when you developed your own way of doing things or were self-motivated to finish an important task.
16. Name a time when your patience was tested. How did you keep your emotions in check?
17. Tell me how you organize, plan, and prioritize your work.
18. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)
19. Share a time when you willingly took on additional responsibilities or challenges. How did you successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and can demonstrate some initiative.)
20. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change? (Make sure the candidate is flexible.)
21. Provide a time when you dealt calmly and effectively with a high-stress situation.
22. Provide an example when your ethics were tested.
23. Walk me through how you would signal workers to discharge, dump, or level materials.
24. Share an experience in which your diligence of inspecting equipment, structures, or materials helped you identify a problem or the cause of a problem.
25. Provide an experience in which you were sensitive to somone's needs or feelings. How did your helpfulness affect your work environment?

26. Name a time when your creativity or alternative thinking solved a problem in your workplace.
27. Share an experience in which your willingness to lead or offer an opinion helped your company.
28. Share an experience in which you successfully coordinated with others. How about a coordination effort
that was not as successful?
29. Tell me about the last time you performed routine maintenance on equipment. How did you determine
when and what type of work was needed?
30. What have you found to be the best way to monitor the performance of your work and/or the work of
others? Share a time when you had to take corrective action.
31. Name a time when you identified strengths and weaknesses of alternative solutions to problems. What was
the impact?
32. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the
situation and outcome?
33. Tell me about your qualifications for and your experience handling vehicles and/or mechanized
equpiment.
