10. Share an effective method you have used to modify the general education curriculum for special-needs students.

11. Provide an experience in which the results of a standardized test helped you to effectively determine a student's strengths and areas of need.

12. Share an effective method you have used to instruct students in daily living skills required for self-sufficiency.

13. Tell me about the different techniques you have used to instruct special needs students in academic subjects.
