

## Transportation Consultant Interview Questions

1. Name a time when your advice to management led to an improvement in your company or otherwise helped your employer.

2. Share an example when you recommended transportation system improvements or projects, based on economic, population, land-use or traffic projections.

3. Describe methods you have found effective to review development plans for transportation system effects, infrastructure requirements, or compliance with applicable transportation regulations.

4. Tell me how you organize, plan, and prioritize your work.

5. What are some long-range objectives that you developed in your last job? What did you do to achieve them?

6. Give me an example of when you thought outside of the box. How did it help your employer?

7. Tell me about an experience in which you analyzed information and evaluated results to choose the best solution to a problem.

8. Would you consider analyzing data or information a strength? How so?

9. Share an example of a time you had to gather information from multiple sources. How did you determine which information was relevant?

10. Share an experience in which your ability to consider the costs or benefits of a potential action helped you choose the most appropriate action.

11. Share an experience in which your understanding of a current or upcoming problem helped your company to respond to the problem.

12. Please share an experience in which you presented to a group. What was the situation and how did it go?

13. How would you rate your writing skills? (Ask for an example that demonstrates great writing skills.)

14. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the situation and outcome?

15. Tell me about the last time you monitored or reviewed information and detected a problem. How did you respond?

16. Name a time when you prepared reports or recommendations on transportation planning.

17. Share an experience you had in dealing with a difficult person and how you handled the situation.

21. Share an example of when you went above and beyond the "call of duty". (Look for answers that show the candidate is dependable.)

22. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)

23. Provide an experience that demonstrates your ability to manage time effectively. What were the challenges and results?

24. Walk me through how you would analyze and interpret data from traffic modeling software, geographic information systems, or associated databases.

25. Share a time when you willingly took on additional responsibilities or challenges. How did you successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and can demonstrate some initiative.)

26. What is the most challenging part of documenting and evaluating transportation project needs and costs?
27. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change? (Make sure the candidate is flexible.)
28. Name a time when you developed design ideas for new or improved transport infrastructure, such as junction improvements, pedestrian projects, bus facilities, and car parking areas.
29. What factors do you consider when producing environmental documents, such as environmental assessments or environmental impact statements?
30. Share an experience in which your willingness to lead or offer an opinion helped your company.
31. Describe methods you have found effective to analyze information related to transportation, such as land use policies, environmental impact of projects, or long-range planning needs.
32. What is the most challenging part of collaborating with engineers to research, analyze, or resolve complex transportation design issues?
33. Provide a time when you dealt calmly and effectively with a high-stress situation.
34. Provide an experience in which you were sensitive to someone's needs or feelings. How did your helpfulness affect your work environment?
35. Name a time when your creativity or alternative thinking solved a problem in your workplace.
36. Share an example when you effectively developed or tested new methods or models of transportation analysis.
37. Tell me about the last time you oversaw the work of someone else. How did you effectively motivate, develop, and direct the worker(s)?
38. What are your computer skills when it comes to developing computer models to address transportation

planning issues? Share an example.

39. How do you stay current in order to analyze transportation-related consequences of federal and state legislative proposals?

40. Describe an experience when you represented jurisdictions in the legislative or administrative approval of land development projects.

41. What kind of experience do you have directing urban traffic counting programs?

42. In your experience, what is the key to collaborate with other professionals to develop sustainable transportation strategies at the local, regional, or national levels?
