1. Describe methods you have effective when observing screen during scan to ensure that image produced is satisfactory for diagnostic purposes, making adjustments to equipment as required.
2. What kind of experience do you have operating ultrasound equipment to produce and record images of the motion, shape, and composition of blood, organs, tissues, or bodily masses, such as fluid accumulations?
3. What is the secret to coordinate work with physicians or other healthcare team members, including providing assistance during invasive procedures? Share an example.
4. What is the most challenging part of supervising or training students or other medical sonographers?
5. Describe an experience in which you identified the educational needs of your students and successfully developed a way to teach/train them.
6. What is the key to success when communicating with the public.
7. Share an experience you had in dealing with a difficult person and how you handled the situation.
8. How do you stay fit in order to perform physical activities that are required in the workplace?
9. Tell me how you organize, plan, and prioritize your work.
10. Share an experience when you applied new technology or information in your job. How did it help your company?
11. Would you consider analyzing data or information a strength? How so?
12. Share an example of a time you had to gather information from multiple sources. How did you determine which information was relevant?
13. Tell me how you decide which images to include, looking for differences between healthy and pathological areas.
14. Walk me through how you provide sonogram and oral or written summary of technical findings to

physician for use in medical diagnosis.
15. Tell me about an experience in which you analyzed information and evaluated results to choose the best solution to a problem.
16. Share an experience in which your attention to detail and thoroughness had an impact on your last company.
17. Provide an example when your ethics were tested.
18. Describe methods you have found helpful when observing and caring for patients throughout examinations to ensure their safety and comfort.
19. Share an effective approach to obtain and record accurate patient history, including prior test results or information from physical examinations.
20. What is the most challenging part of maintaining records that include patient information, sonographs and interpretations, files of correspondence, publications and regulations, or quality assurance records, such as pathology, biopsy, or post-operative reports?
21. Please share an experience in which you presented to a group. What was the situation and how did it go?
22. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the situation and outcome?
23. Name a time when your patience was tested. How did you keep your emotions in check?
24. Provide an experience in which you were sensitive to somone's needs or feelings. How did your helpfulness affect your work environment?
25. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)
26. Provide a time when you dealt calmly and effectively with a high-stress situation.

27. Share an example of when you went above and beyond the "call of duty". (Look for answers that show the
candidate is dependable.)
28. Tell me about a time when you developed your own way of doing things or were self-motivated to finish
an important task.
29. Share a time when you willingly took on additional responsibilities or challenges. How did you
successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and
can demonstrate some initiative.)
30. Provide an example when you were able to prevent a problem because you foresaw the reaction of another
person.
31. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change?
(Make sure the candidate is flexible.)
32. Share an example of when you established and accomplished a goal that was personally challenging. What
helped you succeed?
33. Describe an experience when you performed medical procedures, such as administering oxygen, inserting
and removing airways, taking vital signs, or giving emergency treatment, such as first aid or cardiopulmonary
resuscitation (CPR).
34. Walk me through how you perform legal and ethical duties, including preparing safety or accident reports,
obtaining written consent from patient to perform invasive procedures, or reporting symptoms of abuse or
neglect.
35. What have you found to be the best way to monitor the performance of your work and/or the work of
others? Share a time when you had to take corrective action.
36. Name a time when you identified strengths and weaknesses of alternative solutions to problems. What was
the impact?
37. Share a time when you successfully used scientific rules or methods to solve a problem at work.

38. Share an experience in which personal connections to coworkers or others helped you to be successful in your work. (Make sure candidate works well with others.)
39. Share an experience in which you successfully coordinated with others. How about a coordination effort that was not as successful?
40. How would you rate your writing skills? (Ask for an example that demonstrates great writing skills.)
41. Name a time when your creativity or alternative thinking solved a problem in your workplace.
42. Describe an experience in which you successfully controlled the operation of a difficult system. What made you successful?
43. Please share an experience in which you successfully taught a difficult principle or concept. How were you able to be successful?
44. Share an experience in which your willingness to lead or offer an opinion helped your company.
45. What are some long-range objectives that you developed in your last job? What did you do to achieve them?
46. Provide an experience that demonstrates your ability to manage time effectively. What were the challenges and results?
47. Share an experience in which you conducted a test of a product, service, or process and successfully improved the quality or performance.
48. Share an experience in which you used new training skills, ideas, or a method to adapt to a new situation or improve an ongoing one. (Look for the candidate's ability to learn.)
49. Please share with me an example of how you helped coach or mentor someone. What improvements did
you see in the person's knowledge or skills?

50. Give me an example of when you thought outside of the box. How did it help your employer?
