17. Share an example of when you went above and beyond the "call of duty". (Look for answers that show the candidate is dependable.)

18. Share an effective method you have used to detect the presence of disease or other problems in animals and specimens.

19. Provide an experience in which conducting standardized tests and/or laboratory analyses helped you to effectively evaluate the quantity or quality of substances in a product.

20. Provide an example when your ethics were tested.

21. What is the state of your logs of work activities? What is one thing you would like to improve?

22. Provide an effective method you have used to analyze experimental data and to interpret results.

23. Tell me about a time when you developed your own way of doing things or were self-motivated to finish an important task.

24. Describe an experience in which your participation in the research, development, or manufacturing of medicinal or pharmaceutical preparations benefited your company.

25. Share a time when you willingly took on additional responsibilities or challenges. How did you successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and can demonstrate some initiative.)

26. Provide a time when you were able to identify a complex problem, evaluate the options, and implement a

solution. How did the solution benefit your employer?

27. Share an effective method you have used to ensure that laboratory work complies with standards.

28. Describe the computer, robotic, and/or industrial equipment and applications which you have used.

29. Share an experience in which your ability to consider the costs or benefits of a potential action helped you choose the most appropriate action.

30. How would you rate your writing skills? (Ask for an example that demonstrates great writing skills.)

31. Provide an experience in which you effectively provided support or services for a scientist or engineer.

32. Share an effective method you have used to clean, maintain, and prepare supplies and work areas.

33. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)

34. Tell me about a recent experience you've had working with your hands.

35. Share an experience in which your understanding of a current or upcoming problem helped your company to respond to the problem.

36. Provide an experience in which you successfully solved a difficult problem with laboratory or field equipment.

37. What have you found to be the best way to monitor the performance of your work and/or the work of others? Share a time when you had to take corrective action.

38. Please share an experience in which you presented to a group. What was the situation and how did it go?

39. Provide an example of when you were persistent in the face of obstacles.

40. Share an example of when you established and accomplished a goal that was personally challenging. What helped you succeed?
