

Economic Consultant Interview Questions

1. Share an experience in which your ability to consider the costs or benefits of a potential action helped you choose the most appropriate action.

2. Share an experience in which you effectively supervised research or study projects. What methods made you successful?

3. Name a time when your advice to management led to an improvement in your company or otherwise helped your employer.

4. Describe an experience in which you identified the educational needs of your students and successfully developed a way to teach/train them.

5. Share an experience in which you successfully shared a difficult piece of information. (Make sure that the candidate has open lines of communication.)

6. Tell me how you organize, plan, and prioritize your work.

7. Share an experience when you applied new technology or information in your job. How did it help your company?

8. Give me an example of when you thought outside of the box. How did it help your employer?

9. Tell me about an experience in which you analyzed information and evaluated results to choose the best solution to a problem.

10. Would you consider analyzing data or information a strength? How so?

11. Share an effective approach to working with a large amount of information/data. How has your approach affected your company?

12. Share an example of a time you had to gather information from multiple sources. How did you determine which information was relevant?

13. Provide a time when you were able to identify a complex problem, evaluate the options, and implement a

solution. How did the solution benefit your employer?

14. Name a time when you identified strengths and weaknesses of alternative solutions to problems. What was the impact?

15. Please share an experience in which you presented to a group. What was the situation and how did it go?

16. How would you rate your writing skills? (Ask for an example that demonstrates great writing skills.)

17. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the situation and outcome?

18. Share an experience in which your understanding of a current or upcoming problem helped your company to respond to the problem.

19. Share an experience you had in dealing with a difficult person and how you handled the situation.

20. Share an experience in which your attention to detail and thoroughness had an impact on your last company.

21. Share an example of when you established and accomplished a goal that was personally challenging. What helped you succeed?

22. Share an experience in which you effectively taught theories, principles, and methods of economics. What techniques did you find most effective?

23. What are some long-range objectives that you developed in your last job? What did you do to achieve them?

24. Share an effective method you have used to compile, analyze, and report data to explain economic phenomena and forecast market trends. How do you apply mathematical models and statistical techniques?

25. Provide an experience in which you successfully provided litigation support.

26. Provide an example when your ethics were tested.

27. Share a time when you willingly took on additional responsibilities or challenges. How did you successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and can demonstrate some initiative.)

37. Share an experience in which you used new training skills, ideas, or a method to adapt to a new situation or improve an ongoing one. (Look for the candidate's ability to learn.)

38. What factors do you consider when providing advice on economic relationships?
39. What have you found to be the best way to monitor the performance of your work and/or the work of others? Share a time when you had to take corrective action.
40. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change? (Make sure the candidate is flexible.)
41. Share an experience in which you developed economic guidelines and/or prepared points of view used in forecasting trends and formulating economic policy.
42. Describe a time when you successfully persuaded another person to change his/her way of thinking or behavior.
43. Provide an experience in which conducted research and effectively disseminated research findings.
44. Name a time when your patience was tested. How did you keep your emotions in check?
45. Provide an experience that demonstrates your ability to manage time effectively. What were the challenges and results?
46. Provide a time when you dealt calmly and effectively with a high-stress situation.
47. Share an experience in which you accurately forecasted the production, consumption, and depletion of resources.
48. Describe an effective method you have used to study economic and statistical data in your specialty area.
49. Provide an example of a time when you successfully organized a diverse group of people to accomplish a task.
50. Share an experience in which you successfully coordinated with others. How about a coordination effort that was not as successful?

51. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)

52. Share an experience in which your willingness to lead or offer an opinion helped your company.

53. Provide an experience in which your ability to actively find ways to help people improved your company or your own work ethic.

54. Provide an example when you were able to prevent a problem because you foresaw the reaction of another person.

55. Tell me about an effective recommendation, policy, or plan you formulated which solved an economic problem or interpreted a market.

56. Tell me about a time when your ability to analyze needs and product requirements helped you create an effective design or make an informed decision to benefit your company.

57. Provide an experience in which you were sensitive to someone's needs or feelings. How did your helpfulness affect your work environment?

58. Share an experience in which personal connections to coworkers or others helped you to be successful in your work. (Make sure candidate works well with others.)

59. In your experience, what is the key to ensuring your company was compliant with all laws, regulations and standards that were applicable to your area of responsibility?

60. Tell me about the last time you monitored or reviewed information and detected a problem. How did you respond?
