4. Share an experience in which you successfully shared a difficult piece of information. (Make sure that the
candidate has open lines of communication.)
5. How do you stay fit in order to perform physical activities that are required in the workplace?
6. Tell me how you organize, plan, and prioritize your work.
7. Share an experience when you applied new technology or information in your job. How did it help your
company?
8. Give me an example of when you thought outside of the box. How did it help your employer?
9. Tell me about an experience in which you analyzed information and evaluated results to choose the best
solution to a problem.
10. Tell me about the last time you monitored or reviewed information and detected a problem. How did you
respond?
11. Share an example of a time you had to gather information from multiple sources. How did you determine
which information was relevant?
12. What is the key to success when communicating with the public.
13. Please share an experience in which you presented to a group. What was the situation and how did it go?
14. Provide an experience in which you were sensitive to somone's needs or feelings. How did your
helpfulness affect your work environment?

15. How do you balance cooperation with others and independent thinking? Share an example. (Try to
determine if the candidate has a cooperative attitude or is otherwise good-natured.)
16. Provide an example of a time when you successfully organized a diverse group of people to accomplish a
task.
17. Provide an example when your ethics were tested.
18. In your experience, what is the key to ensuring your company was compliant with all laws, regulations and
standards that were applicable to your area of responsibility?
19. Share an experience in which your attention to detail and thoroughness had an impact on your last
company.
20. Share an example of when you went above and beyond the "call of duty". (Look for answers that show the
candidate is dependable.)
21. Name a time when your patience was tested. How did you keep your emotions in check?
22. Provide an example when you were able to prevent a problem because you foresaw the reaction of another
person.
23. Share an experience in which conferring with staff helped you to effectively evaluate, plan, and/or modify
patient treatments.
24. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change?
(Make sure the candidate is flexible.)
25. Share an experience in which personal connections to coworkers or others helped you to be successful in
your work. (Make sure candidate works well with others.)
26. Describe your experience administering therapeutic exercises, massage, aquatic physical therapy, and
modality treatments.

27. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the
situation and outcome?
28. Share an effective method you have used to instruct caregivers and family members on patient therapeutic
activities and treatment plans.
29. Provide a time when you dealt calmly and effectively with a high-stress situation.
30. Share a time when you willingly took on additional responsibilities or challenges. How did you
successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and
can demonstrate some initiative.)
31. Describe your experience measuring range-of-joint motion, body parts, and vital signs.
32. Provide an experience in which your ability to actively find ways to help people improved your company
or your own work ethic.
33. What have you found to be the best way to monitor the performance of your work and/or the work of
others? Share a time when you had to take corrective action.
34. Share an experience in which you successfully fit patients for orthopedic braces, prostheses, and/or
supportive devices.
35. Share an experience in which your diligence of inspecting equipment, structures, or materials helped you
identify a problem or the cause of a problem.
36. Provide an experience in which you effectively trained patients in the use of orthopedic braces, prostheses,
and/or supportive devices.
37. What are some long-range objectives that you developed in your last job? What did you do to achieve
them?
38. Name a time when you identified strengths and weaknesses of alternative solutions to problems. What was
