

## Pharmacy Consultant Interview Questions

1. Share an experience you had in dealing with a difficult person and how you handled the situation.
2. Describe an experience in which you successfully assessed the identity, strength, and purity of medications.
3. What is the most challenging part of budgeting for you?
4. Name a time when your advice to management led to an improvement in your company or otherwise helped your employer.
5. Provide an example of when you set expectations and monitored the performance of subordinates. What guidance and direction did you find most effective?
6. Describe an experience in which you identified the educational needs of your students and successfully developed a way to teach/train them.
7. Provide an example of a time when you successfully organized a diverse group of people to accomplish a task.
8. What is the key to success when communicating with the public.
9. Describe a time when you successfully provided personal assistance to a coworker or patron.
10. Share an experience in which you successfully shared a difficult piece of information. (Make sure that the candidate has open lines of communication.)
11. Tell me how you organize, plan, and prioritize your work.
12. Share an experience when you applied new technology or information in your job. How did it help your company?
13. Tell me about an experience in which you analyzed information and evaluated results to choose the best solution to a problem.
14. Would you consider analyzing data or information a strength? How so?

15. In your experience, what is the key to ensuring your company was compliant with all laws, regulations and standards that were applicable to your area of responsibility?

16. Share an effective approach to working with a large amount of information/data. How has your approach affected your company?

17. Tell me about the last time you monitored or reviewed information and detected a problem. How did you respond?

18. Share an example of a time you had to gather information from multiple sources. How did you determine which information was relevant?

19. Name a time when you identified strengths and weaknesses of alternative solutions to problems. What was the impact?

20. Share a time when you successfully used scientific rules or methods to solve a problem at work.

21. Please share an experience in which you presented to a group. What was the situation and how did it go?

22. How would you rate your writing skills? (Ask for an example that demonstrates great writing skills.)

23. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the situation and outcome?

24. What have you found to be the best way to monitor the performance of your work and/or the work of others? Share a time when you had to take corrective action.

25. Provide an effective method you have used to provide information regarding drug interactions, side effects, dosage, and/or proper medication storage.

26. Share an effective method you have used to ensure prescriptions are accurate, contain needed ingredients, and are suitable.

27. Provide an example when your ethics were tested.

28. Share an experience in which your attention to detail and thoroughness had an impact on your last company.

29. Share an experience in which your ability to consider the costs or benefits of a potential action helped you choose the most appropriate action.

30. Please share an experience in which you successfully taught a difficult principle or concept. How were you able to be successful?

40. Provide a time when you dealt calmly and effectively with a high-stress situation.

41. Provide an experience that demonstrates your ability to manage time effectively. What were the challenges and results?

42. Name a time when your patience was tested. How did you keep your emotions in check?

43. Provide an effective method you have used to advise customers on the selection of medication brands, medical equipment, and/or healthcare supplies.

44. Share an experience in which you successfully taught pharmacy students serving as interns.

45. Share an experience in which your diligence of inspecting equipment, structures, or materials helped you identify a problem or the cause of a problem.

46. Provide an experience in which you were sensitive to someone's needs or feelings. How did your helpfulness affect your work environment?

47. Share an experience in which collaborating with other health care professionals helped you to accurately evaluate the effectiveness of a drug or drug regimen.

48. Tell me about a specialized service you provided to help patients manage a medical condition, e.g. high blood pressure.

49. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)

50. Provide an experience in which you successfully analyzed prescribing trends to monitor patient compliance and to prevent excessive usage or harmful interactions.

51. Share an experience in which you effectively managed pharmacy operations. What methods made you successful?

52. Tell me about a time when you developed your own way of doing things or were self-motivated to finish an important task.

53. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change? (Make sure the candidate is flexible.)

54. Share a time when you willingly took on additional responsibilities or challenges. How did you successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and can demonstrate some initiative.)

55. In your experience, what is the key to developing a good team? (Look for how they build mutual trust, respect, and cooperation.)

56. Share an experience in which your willingness to lead or offer an opinion helped your company.

57. Tell me about your experience assaying radiopharmaceuticals, verifying rates of disintegration, and calculating the volume required to produce the desired results.

58. Tell me about the last time you oversaw the work of someone else. How did you effectively motivate, develop, and direct the worker(s)?

59. Provide a time when you were able to identify a complex problem, evaluate the options, and implement a solution. How did the solution benefit your employer?

60. What are some long-range objectives that you developed in your last job? What did you do to achieve them?

61. Tell me about a health promotion or prevention activity which you developed and/or maintained.

62. Give me an example of when you thought outside of the box. How did it help your employer?

63. Provide an example of when you were persistent in the face of obstacles.

64. Share an example of when you established and accomplished a goal that was personally challenging. What helped you succeed?

65. Describe a time when you successfully persuaded another person to change his/her way of thinking or behavior.

66. Share an experience in which you used new training skills, ideas, or a method to adapt to a new situation or improve an ongoing one. (Look for the candidate's ability to learn.)

67. Tell me about a recent experience you've had working with your hands.

68. Share an experience in which you published educational information for other pharmacists, doctors, and/or patients.

69. Share an experience in which personal connections to coworkers or others helped you to be successful in your work. (Make sure candidate works well with others.)

70. Tell me about your last experience recruiting, interviewing, or hiring an employee. What techniques did you find most effective in finding the right person for the job?

71. Name a time when your creativity or alternative thinking solved a problem in your workplace.

72. Tell me about a time when your ability to analyze needs and product requirements helped you create an effective design or make an informed decision to benefit your company.

73. Describe an experience in which your ability to work well with others and reconcile differences helped your company or employer. (Make sure the candidate knows how to negotiate.)
