4. Describe an experience in which you identified the educational needs of your students and successfully developed a way to teach/train them.

5. Share an experience you had in dealing with a difficult person and how you handled the situation.

6. Share an experience in which you successfully shared a difficult piece of information. (Make sure that the candidate has open lines of communication.)

7. Tell me how you organize, plan, and prioritize your work.

8. Share an experience when you applied new technology or information in your job. How did it help your company?

9. Give me an example of when you thought outside of the box. How did it help your employer?

10. Tell me about an experience in which you analyzed information and evaluated results to choose the best solution to a problem.

11. Would you consider analyzing data or information a strength? How so?

12. Share an effective approach to working with a large amount of information/data. How has your approach affected your company?

13. Share an example of a time you had to gather information from multiple sources. How did you determine which information was relevant?

44. Name a time when your patience was tested. How did you keep your emotions in check?

45. Tell me about the last time you monitored or reviewed information and detected a problem. How did you respond?

46. Name a time when your creativity or alternative thinking solved a problem in your workplace.

47. Provide an experience in which you were sensitive to someone's needs or feelings. How did your helpfulness affect your work environment?

48. What factors do you consider when selecting class materials and supplies?

49. Provide an example when you were able to prevent a problem because you foresaw the reaction of another person.

50. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change? (Make sure the candidate is flexible.)

51. Provide an example of a time when you successfully organized a diverse group of people to accomplish a task.

52. Provide a time when you dealt calmly and effectively with a high-stress situation.

53. Describe an experience in which you performed administrative duties, e.g. serving as department head.
54. Share an experience in which collaborating with colleagues helped you to address a difficult issue.
55. Name a time when your advice to management led to an improvement in your company or otherwise helped your employer.
56. In your experience, what is the key to ensuring your company was compliant with all laws, regulations and standards that were applicable to your area of responsibility?
57. Share an experience in which personal connections to coworkers or others helped you to be successful in your work. (Make sure candidate works well with others.)
58. Describe your experience serving on academic and/or administrative committees. How did your service benefit your school?
59. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)
60. Provide an effective method you have used to compile bibliographies for outside reading assignments.
61. Provide an experience that demonstrates your ability to manage time effectively. What were the challenges and results?
62. Share a time when you successfully used scientific rules or methods to solve a problem at work.
63. Provide an example of when you set expectations and monitored the performance of subordinates. What guidance and direction did you find most effective?
64. Tell me about a time when your ability to analyze needs and product requirements helped you create an effective design or make an informed decision to benefit your company.
65. Share an experience in which your participation in student recruitment, registration, and/or placement

activities benefited your school.

66. Tell me about the last time you oversaw the work of someone else. How did you effectively motivate, develop, and direct the worker(s)?

69. Describe a time when you successfully provided personal assistance to a coworker or patron.

70. Provide an effective method you have used to procure external research funding.

72. Share an experience in which you successfully acted as an adviser to a student organization.
