14. How do you balance cooperation with others and independent thinking? Share an example. (Try to determine if the candidate has a cooperative attitude or is otherwise good-natured.)

15. Name a time when your patience was tested. How did you keep your emotions in check?

16. Tell me how you organize, plan, and prioritize your work.

17. Provide a time when you worked in a rapidly evolving workplace. How did you deal with the change? (Make sure the candidate is flexible.)

18. Describe an example when you installed or replaced machinery, equipment, and new or replacement parts and instruments, using hand or power tools.

19. Name a time when you diagnosed electrical problems and installed and rewired electrical components. Were you successful?

20. How often do you adjust, maintain, and repair tools, equipment, and machines, and assist more skilled workers with similar tasks?

21. Provide an experience in which you were sensitive to someone's needs or feelings. How did your helpfulness affect your work environment?

22. Provide a time when you dealt calmly and effectively with a high-stress situation.

23. Describe methods you have found effective to prepare work stations for use by mechanics and repairers.

24. Tell me about the last time you performed routine maintenance on equipment. How did you determine when and what type of work was needed?

25. Share a time when you willingly took on additional responsibilities or challenges. How did you successfully meet all of the demands of these responsibilities? (Make sure the candidate is a self-starter and can demonstrate some initiative.)

26. What is the most challenging part of tending and observing equipment and machinery to verify efficient and safe operation?

27. Name a time when you identified strengths and weaknesses of alternative solutions to problems. What was the impact?

28. Tell me about your last experience doing repair work. How did you determine what tools you needed?

29. Describe an experience in which you successfully controlled the operation of a difficult system. What made you successful?

30. Provide an example of a time when you were able to demonstrate excellent listening skills. What was the situation and outcome?
